Saint Kitts and Nevis

Saint Kitts and Nevis is an island in the Caribbean Sea, about one-third of the way from Puerto Rico to Trinidad and Tobago.



The Federation of St. Kitts and Nevis (St. Kitts) is a twin-island nation located in the British West Indies.

It is situated about 1,300 miles southeast of Miami, Florida and is approximately 50-70 miles south of St. Barts, St. Maarten and Anguilla and 60 miles west of Antigua. This English-speaking country obtained independence from the United Kingdom in 1983 but remains a member of the British Commonwealth.

The Federation of St. Kitts and Nevis has a population of 50,000 and boasts a 95% literacy rate. The island of St. Kitts is 68 square miles and most of the towns and villages are scattered around the periphery of the island are generally on the coast with a lush green forest located more towards the center of the island.

The Island has a democratically elected government and the Honorable Dr. Terrance Drew is the Prime Minister.

St. Kitts allows for individuals to acquire citizenship through a government sponsored investment program.

Those meeting the requirements of the program are rewarded with full citizenship, including a passport and the right to permanently reside and work in St. Kitts. This is the oldest economic citizenship program of its kind globally and has been in place since 1984. One route to citizenship is for applicants to make a minimum investment of US\$ 325,000 (plus associated government fees) in a government approved real estate development program.





